



Episode 6: Handout #5 – Coroner Report (Dr. Ira Gorschzach)

<p>DESCRIPTION OF CORPSE: DRESSED IN OFFICE CASUAL WORK CLOTHES, WEARING A STAINED LABORATORY COAT (C2H2O4, CUCL2, HCL, H2O2)</p> <p>EXTERNAL INJURIES: 1. PERFORATING WOUNDS, ONE TO THE HEAD AND THREE TO THE UPPER CHEST. WOUNDS WERE PUNCTURE WOUNDS WITH CONCURRENT EXIT WOUNDS, DELIVERED THROUGH AN CONICALLY-TAPERED FIELD POINTS, PROJECTED FROM A BOW OF AT LEAST 460 FPS CALCULATING TO A PULL STRENGTH OF 140 FT-LBS AT A FULL 32" BOW (SEE ADDENDUM A.2., VARIATIONS ON FPS BASED ON VARIOUS BOW LENGTHS AND MODELS). 2. PARTIALLY HEALED LIGATURE MARKS ON BOTH WRISTS.</p> <p>INTERNAL INJURIES: BLOOD LOSS, TRAUMATIC BRAIN DAMAGE, HEART/AORTA TRAUMA, COLLAPSED LEFT LUNG, SHATTERED STERNUM. THREE BROKEN LOWER RIBS UNRELATED TO PERFORATIONS.</p>			
<p>MEDICAL DIAGNOSIS: IMMEDIATE DEATH FROM MULTIPLE AND NEAR SIMULTANEOUS ARROW WOUNDS</p>	<p>NOTES: HOMICIDE, BOW WITH FIELD HUNTING ARROWS. VICTIM WAS IN A DEFENSELESS POSTURE FACING THE ATTACK. ARROWS WERE REMOVED MEDICALLY AND WITH PRECISION, WITH NO ADDITIONAL TRAUMA FROM EXCISION.</p> <p>SELF-INFLICTED SYMMETRICAL CUTS ON UPPER FOREARM, SEE APPENDIX B (NOTATION REQUESTED: N. BRONSON).</p>
